## TERMS

1. Children age 6 and younger cannot participate in group lessons. They do receive a free lift ticket only, if accompanied by a full paying adult/parent (max. two children per adult). (No free rental, lesson or snow tubing.)
2. In order to secure group rentals a major credit card will be required.
3. All rental/lesson purchasers must sign a release of liability, parent/legal guardians must sign on behalf of children age 7 – 17.
4. Group agrees to make final accounting of all monies and unsold tickets no later than the first day of arrival unless otherwise specified. Resale of tickets is unlawful and is subject to prosecution.
5. To receive Regular Group Rates the group must place their reservation for a minimum of 15 persons, at least 48 business hours prior to trip date (sales office hours are Mon thru Fri 9 – 5) accompanied by a \$100.00 non – refundable deposit, payable by check, credit card or money order.
6. You will receive one FREE lift ticket for every 15-lift tickets purchased; no comps are issued on rental or lesson purchases.
7. Tickets purchased for a particular time and category are valid ONLY during that time period, i.e. weekday tickets valid weekdays only, etc.
8. If additional tickets are needed on the day of your visit, you MUST present your copy of the reservation form at the Group Welcome Center and pay in full to receive the Group rate. Complimentary tickets are not issued on lift tickets purchased on the day of visit.
9. Meal Vouchers are non-refundable, they have no cash value, no change will be given. Meal Vouchers apply to specific menu combinations only.
10. Non-Profit/Tax exempt Groups must show Valid NJ TAX EXEMPT FORM (ST-4 or ST-5) at time of reservation.
11. Mountain Creek reserves the right to limit/close operations of any facility for capacity limitations, safety and operating reasons, including inclement weather.
