- To receive group rates the group must place their reservation for a minimum of 8 persons at least 48 business hours prior to trip date.
- All reservations must be accompanied by payment in full (\$100.00 of this payment is NON-REFUNDABLE). Payable by organization check, credit card or money order. **And if renting Completed Group Rental Sign up worksheet to ensure availability of bike sizes.**
- If it becomes necessary for you to cancel your reservation, we must be notified at least 24 hours in advance of your scheduled arrival time to qualify for a full refund. (if no one is available to answer your call please leave a message at 862-307-7396) Reservations cancelled within 24 hours of the scheduled arrival time will be charged for one (1) full day rental. In the rare event that the Bike Park is closed due to severe, inclement weather, all bike reservations will be cancelled without penalty.
- Rain Policy:** In the event that the Bike Park is closed fully due to severe or inclement weather, all bike reservations will be cancelled without penalty.
- Children 5 and under cannot participate.
- In order to secure group rentals a major credit card will be required.
- You will receive one complimentary lift ticket for every 10 lift tickets purchased (this includes lift tickets sold as part of packages). No comps are given for rental or lesson purchases.
- Resale of tickets is unlawful and subject to prosecution.
- Non-profit/Tax exempt groups must show valid NJ TAX EXEMPT FORM (ST-4 or ST-5) at time of reservation.
- Mountain Creek reserves the right to limit/close operations of any facility for capacity limitations, safety and operating reason including inclement weather. Hours of operation are subject to change without notice.
- All Riders are required to wear helmets and closed toe shoes.
